Multi-Generation Mini Goldendoodle Purchase Contract

Sire: Rosco Dam: Barklee Sparkles

\$3000 without Breeding Rights, Male or Female

At time of purchase: Female With Breeding Rights \$4000

At time of purchase: Male With Breeding Rights \$3750

*** The additional breeding right fee is due by puppy's first birthday if there is no veterinary documentation of sterilization received by breeder within puppy's first year of life, or once buyer decides they would like to purchase breeding rights. ***

BUYER AGREES:

1. To have puppy examined within 7 calendar days of purchase/take home by a licensed veterinarian to validate the health guarantee and the health of the puppy. Any findings need to be documented and breeder needs to be notified on the day of the examination.
2. The puppy is not being purchased for resale and will never be resold to a pet shop, puppy mill, animal shelter or agent of the same. Should buyer need to rehome the purchased animal, breeder will have first offer to buy back the animal for no more than \$500.
3. To continue with the appropriate vet exams and follow all recommendations of vet in regard to shots and proper care. Failure to comply with and provide documentation of these vet visits voids all guarantees offered by breeder.
4. The value of the puppy for the purpose of this guarantee is solely the purchase price of the puppy and does not include any additional expenses such as shipping, vet exams, or other cost incurred by the purchaser/owner.
5. To keep the puppy in good physical condition and proper weight. Provide proper care and nourishment.
6. Puppy is being purchased as a "pet only". Puppy will be spayed or neutered within one year of birth, and proper documentation will be sent back to the breeder UNLESS breeding rights were purchased for \$500 male/\$750 female.
7. Deposit and subsequent payments for puppy will be paid via Cash, Venmo or Paypal only, to document receipt of payment. Check/Credit Cards are not accepted.
8. To stay in regular contact with the breeder and provide regular updates on health and personality. Email, Text, and Facebook are options to keep communication open. Photos that are sent to breeder may be used for social media purposes on breeder's behalf.

BREEDER AGREES:

1. Breeder guarantees that puppy has had proper care to date and has been examined by a licensed veterinarian and has been determined to be healthy. Puppy has received first shots and has been dewormed at the proper times. Records will be provided to buyer at the time of purchase. If within 7 calendar days of receiving the puppy he/she is examined by a licensed and reputable veterinarian, and the health of the puppy is found to be at risk due to a congenital defect, owner will notify breeder on that day and provide a written document from 2 veterinarians describing the puppy's condition within 5 business days. Owner shall return the puppy and papers to the breeder within 3 days of the last exam for a full refund. Conditions not included: worms, fleas, mites, coccidia, giardia, or any other parasites as they are common in dogs and puppies. If puppy is taken out of the area local to the breeder, return fees will be at the expense of the buyer.
2. Breeder is not responsible if puppy contracts a communicable disease after leaving breeder's home. Parvo is extremely contagious, and every possible care will need to be taken in order to protect the puppy during the travel from breeder's home to buyer's home.
3. **1-year health guarantee** – Breeder guarantees puppy against any congenital defect and also against a defect that causes death or makes euthanasia necessary, for one full year from birth. In the event of such a defect, a puppy from an upcoming litter will be provided. Should no litters be expected within one calendar year of serious defect notification, full purchase price will be refunded. Please note that umbilical hernias or luxating patellas typically resolve as puppies grow and are not considered a serious defect as described above. Should either of these conditions pertain to a particular puppy, buyer has the option to return the puppy to the breeder for a 75% refund if notified within 7 calendar days of receiving the puppy if not comfortable with the diagnosis, or of breeder paying up to \$150 towards any procedures needed to correct the condition. If buyer chooses to have breeder assist with the cost of a procedure to repair either condition, breeder must be given permission to discuss diagnosis with the veterinarian and the payment of \$150 will be paid directly to the veterinarian.
4. In the case of sudden demise of puppy within one year of birth, breeder must receive a written notice of the puppy's death from a licensed veterinarian along with a necropsy report stating the cause of death. This is required so that

breeder can make appropriate decisions regarding future breeding pairs within the breeding program of Goldenhearted Doodles.

5. Breeder guarantees good health of the puppy and no hereditary defects for one full year after birth. Breeder does not guarantee against communicable diseases such as parvo, distemper, rabies, etc.
6. In the event that a nonfatal congenital defect is detected/discovered within the first 12 months of the puppy's life, the breeder agrees to compensate the buyer in one of the following ways:
 1. Buyer gives the puppy back to the breeder and receives a puppy from an upcoming litter of the same breed (goldendoodle, various generations)
 2. Should buyer choose to keep the puppy, breeder pays the veterinary bill directly to the veterinarian for surgery or appropriate treatment to correct the defect up to 75% of the purchase price of the puppy, not including breeding right fees. Breeder reserves the right to consult with various veterinarians of own choice to discuss best course of treatment for diagnosis.
7. Breeder will provide CKC pre-registration and Embark genetic results for the selected puppy, as well as Embark genetic results and OFA results for both parents upon request of the buyer.
8. Breeder agrees to have raised puppies for the first eight weeks following the BadAssBreeder program to help ensure a well-rounded puppy for your family!

To be covered by this guarantee, puppy must be owned by original buyer/owner as designated below and have completed all aspects of buyer's responsibilities as described above under "Buyer Agrees #1-8").

The following will void all health guarantees as described above:

1. Evidence of abuse or neglect.
2. Previous related trauma (broken bones, related injuries, etc.)
3. Dog has been subjected to strenuous exercise before one year of age (at which point bones are fully developed)
4. Dog has been bred to another dog before **12 months** of age, regardless of whether breeding rights were purchased.

Buyer, please call the breeder with any questions or concerns about your new puppy! We carefully select families to take our puppies and want to maintain a life-long friendship for the sake of the puppy and for the sake of our sires and dams within our breeding program. If for whatever reason you can no longer care for your puppy we will ALWAYS take them back, no questions asked!

HEALTH GUARANTEE APPLIES TO THE ORIGINAL BUYER AS DOCUMENTED ABOVE AND IS NOT TRANSFERABLE.
